

## Editorial

It is a known fact that the crisis has hit Greece and the countries in the South of the EU severely. The harsh socio-economic situation in those countries and the difficult negotiations with the Troika have been dominating in the media since the outbreak of the crisis. But more and more we start to be aware of the fact that the socio-economic realities in the countries of Central and Eastern Europe (CEE) which are members of the EU but most of them not of the Eurozone, are extremely difficult. It has been assumed that in most of those countries the crisis has not hit as hard as they did not have toxic assets either in their banking system or overall in the economy. In reality only Poland managed to escape recession, a recession which was added to mostly weak economies depending to great extent on foreign capital.

In order to fill this gap of knowledge and awareness, an [ETUI Working paper](#) which is due to be published in a couple of days opens the CEE 'black box' and shows how exactly the new EU member states have suffered from the crisis and what remedies they have applied. Although the author Magdalena Bernaciak insists very much on the differentiation of the CEE countries, which is of crucial importance if we want to understand what is going on in this part of Europe, a common characteristic of all countries can be discerned. Collective labour relations have come under pressure everywhere and it is likely that in the future collective bargaining in CEE will remain limited. However, [as another ETUI report shows](#), there are new, innovative forms of resistance to austerity which challenge the gloomy vision of the labour movement in CEE countries. These new practices could even trigger a renewal of labour organisations in the rest of Europe but this still remains to be seen.

The ETUI will follow these developments closely via the trade union related research network (TURI) which has recently been enlarged with more members from CEE such as to cover developments in Bulgaria, Hungary, Poland, Lithuania and Slovenia. In this newsletter you will find a short report of the latest meeting of this network in Amsterdam.
