Editorial

European integration is subject to a period of great uncertainty. The financial crisis was followed by the euro crisis and the unemployment crisis; now we are faced with the refugee crisis of which no one can accurately predict the outcome. In the midst of the turmoil, one government is demanding a 'half-membership' status that would allow it to hold on to the best of the EU and to jettison the 'worst'. Is the United Kingdom to be taken out of Europe? Is Greece to be taken out of Schengen? Are barbed wire fences to be erected at the Austrian and Danish borders and elsewhere? Are the Visegrad countries to be granted special status? Utter confusion seems to be everywhere.

Those of us who observed completion of the internal market, the launching of the single currency, the fall of the Berlin Wall and the reunification of the continent have in the last few months looked on aghast as the European Union took several unbelievable strides ... backwards. After a protracted and painstaking labour of realisation that we European countries are all in the same boat, this hard achieved insight has been suddenly shattered. Instead of new prospects or ambitions, we are faced with a void.

In this context the European Commission's plan to bring the question of fundamental social rights back on to the agenda is to be welcomed. The initiative may or may not come to something; yet to seek to restore some prospect of social progress for all Europeans, including the right to decent wages, to collective representation, to social inclusion, and to protection against abusive social practices, is indeed a way of helping citizens and workers to regain their bearings and of putting new wind into Europe's sails. Social progress is a sine qua non condition of any endeavour to make European citizenship a meaningful reality. The boldness of this wager is better than the mediocrity of a 'shut-down-the-borders' mentality. It remains to hope that visionary leaders will prove willing to enact such a wager.

Social partners and the collaborative approach are key to the green transition of the Ruhr region

During a Monthly Forum held on 1 February, ETUI senior researcher Béla Galgóczi presented the main findings of a recent paper on the economic and industrial restructuring process of the Ruhr areas. 'We are facing a long-term challenge: Europe needs to reach carbon neutrality by 2050, according to COP21. This means that Europe needs to double the effort it made between 1990 and 2020 in order to exit from fossil fuel in 2050', said Béla Galgóczi, presenting a recent paper published in the Journal of Labour Research on 'The long and winding road from black to green. Decades of structural change in the Ruhr region'.

From 2 to 5 February 2016 15 trade union trainers from nine European countries meeting in Kiljava (Finland) became acquainted with the concept, methodology and materials necessary to teach the 'Introductory course in Project work' at national level. The final goal, spreading the Project work/management methodology among ETUC members, is helping trade unions to manage their resources more efficiently but also to promote networking and interaction between them and to reinforce a common working culture that helps to enhance trade union cooperation in Europe.

Course on informal economy in Sofia



From 26 to 28 January the ETUI, CITUB and KOZ held a course in Sofia on the informal economy. Unionists from six European countries and with professional and union experience in social security and tax administration, in the police and the educational environment, but also in migration and training, worked on a subject that is very present also due to the new challenges generated by European migration and asylum policy. The dynamic character of the course enabled intensive work to take place on the main concepts of informal economy and profiling axes to share and improve existing trade union strategies.
