Editorial

In his State of the Union speech last Wednesday, the President of the European Commission, Jean-Claude Juncker, announced his intention to lay out a long-term vision for the future of the European Union at the occasion of the 60th anniversary of the Treaties of Rome. This White Paper will consider, among other things, how to strengthen and reform the Economic and Monetary Union. Juncker also put forward some concrete actions for the coming year, which will be 'decisive if we want to reunite our Union'. These actions will focus on the preservation of European common values, such as the free movement of workers, social justice, a fair taxation system, and the protection of workers and industries through social dialogue. He also reiterated the important role of the euro in protecting the Eurozone from financial instability and in creating jobs, and insisted that Europe must 'invest strongly in its youth, in its jobseekers, in its start-ups'. However, as the ETUC pointed out in its official response, there were no new policy proposals to tackle low wages, precarious work, the exploitation of migrant workers and social dumping.

The ETUI has been working on all these issues for a long time, underlining the importance of the stabilisation of the Eurozone for social and economic recovery in the short or medium term. In the coming month we will be hosting an event with Maurizio Ferrera, professor of political science at the University of Milan, who is one of Europe's foremost experts on the welfare state. He will argue that the reconciliation between welfare and the EU is not a "mission impossible". A new series of events – the Foresight debates – will be launched on 24 October with a talk by Karl Falkenberg, Senior Adviser to the European Commission (EPSC), on a 'European Vision for Sustainability'. This series aims to open up the discussion on the global trends that pose diverse challenges to our societies and economies.
